I request permission to sell at the Brightmoor Artisans Farmers' Market (BAFM). I have read and agree to abide by BAFM's Rules and Regulations as well as all laws, codes and regulations, to cooperate with market management and to pay the required stall fee. I agree to indemnify and hold harmless BAFM, the City of Detroit, their officers, directors, employees, representatives and agents, from and against all liability, claims, demands, losses, damages, levies and causes of action or suits of any nature whatsoever, arising out of or related to my activities at BAFM. I understand that this application relates only to the products listed herein and that any further products will require another application. Unless otherwise specified in BAFM Rules and Regulations, any violations of this agreement may result in suspension or termination from the Market at the discretion of management. Market rules are subject to change at any time for any reason, with 7 days notice given to current market vendors before they take effect. I understand that market assignments may not be transferred to any other party. I certify that the products above are produced in accordance with all county, state and federal laws and grown or produced by myself unless otherwise noted.

Duration of the Agreement: This agreement applies to the 2017 BAFM season (May 4th – October 5th) and in no way implies acceptance in the future.
